OUTDOOR RECREATION & NATURE TOURISM INITATIVE

The outdoor Nature Tourism initiative is focused on leveraging natural resources with economic opportunity. This initiative supports the development and promotion of recreational tourism as a target business sector by enhancing the region's cultural, recreational and retail/restaurant/ service amenities. Significant accomplishments include the following:
